Accordingly, Mr. Ratanchand D Jain acquired management control of Company and got appointed on the Board of Company w.e.f. 12.10.2019. Post Open Offer the Shareholding of New Promoter and Promoter Group is 3,84,36,873 Equity Shares representing 48.99% of the paid up capital of Company. Further the company has received necessary disclosures for the same.
